

General Webex Information

Important Buttons to Take Note of:

Safety is Our Top Priority

- **Safety Message: Heat Stress**
 - Heat stress is overexposure to or overexertion in excess environmental temperatures, which could lead to heat cramps, heat exhaustion, or heat stroke.
 - Prevention
 - Drink plenty of water or nonalcoholic fluids regularly and often.
 - Perform the heaviest work during coolest part of the day.
 - Take frequent, short breaks in cool, shaded areas to allow body to cool down.
 - Wear lightweight, light-colored, loose-fitting clothing to allow free air movement.





CNS hosts Virtual Business Forum







Y-12 & Pantex are Production Sites in the NNSA Nuclear Security Enterprise



The NNSA Production Office and CNS manages both the Pantex Plant and the Y-12 National Security Complex

Pantex a Proud History of Service to our Nation



- **1942** – Last of 14 bomb-loading plants constructed during WWII. Produced 250- and 500-pound bombs during WWII. Peak employment 5,254 (60% female)
- **1945** – Pantex closed
- **1947** – Texas Technological College established agricultural research farm
- **1951** – Pantex recaptured by the Atomic Energy Commission and refurbished for nuclear weapons work
- **1956** – New weapons designs and facility designs come to Pantex operations
- **1960** – New high explosives mission
- **1965** – Surveillance mission begins
- **1991** – Disassembly mission

Y-12 a History of Transformation

- Construction began in 1943 as part of Manhattan Project
- During the Cold War, some 8,000 people produced weapon secondaries
- Transformation is underway to create a modern facility that will meet future mission needs



Mission

- Maintain the safety, security, and effectiveness of the nation's nuclear deterrent
- Reduce global nuclear security threats and strengthen the nuclear enterprise
- Provide safe and effective integrated nuclear propulsion systems for the U.S. Navy
- Strengthen key science, technology, and engineering capabilities
- Modernize the national security infrastructure

- D&D of unneeded facilities is accomplished to eliminate costly upkeep and reduce risk.




Age of Facilities




Pantex and Y-12 Infrastructure Projects

Acquisition Process

- The primary objective of CNS Procurement is to obtain the best value in the products and services purchased. All CNS procurements emphasize safety, security, mission delivery, quality and cost efficiency.
- Procurement Methods:
 - Existing Subcontracts –Basic Ordering Agreements, Enterprise Wide Agreements
 - Purchase Cards (P-cards)
 - Formal Solicitation and Award Process




Acquisition Process Continued

- Commercial items under \$10,000 maybe purchased with a P-card.
- The majority of dollars spent under \$250,000 are evaluated on a competitive basis and are typically set-aside for small business participation.
- Purchases over \$250,000 are competitively solicited under a formal written solicitation. As a general rule, awards are made to the lowest priced technically acceptable offer or to the offeror determined to represent the best value to Consolidated Nuclear Security, LLC and the Government.
- The CNS Small Business Program ensures the utilization of small businesses by providing the maximum practicable opportunities to participate in subcontracting of services and products. Small businesses include businesses classified as small, small disadvantaged, woman-owned, HUBZone, veteran-owned, and service disabled veteran-owned small businesses.



